

DISTRICT OF FORT ST. JAMES
CEMETERY BYLAW AMENDMENT
BYLAW NO. 931, 2013

A bylaw to amend District of Fort St. James “Cemetery Bylaw No 866, 2009.”

The Council of the District of Fort St. James enacts as follows:

1. This bylaw may be cited as “Cemetery Bylaw Amendment, Bylaw No. 931, 2013.”
2. District of Fort St. James “Cemetery Bylaw No 866, 2009” is amended as follows:
 - 2.1 Sections 5(j) through 5(o) are inserted following section 5(i):
 - 5(j) “*Cemetery*” means land that is set apart or used as a place of burial of *human remains* or *cremated remains* and includes any incidental or ancillary buildings on the land;
 - 5(k) “*Child*” means any person one year old, and up to and including twelve years of age;
 - 5(l) “*Cremated Remains*” means human bone fragments left after *human remains* are cremated;
 - 5(m) “*Human Remains*” means
 - (i) a dead human body in any stage of decomposition, or
 - (ii) a body of a stillborn infant in any stage of decomposition;
 - 5(n) “*Infant*” means any stillborn infant or person up to the age of one year;
 - 5(o) “*Interment*” means burial of *Human Remains* or *Cremated Remains* in a *plot*.
 - 2.2 Section 36 is deleted and replaced as follows:
 36. A tablet type memorial must:
 - (a) have a top surface that measures no more than 30 cm x 50 cm;
 - (b) be placed with the top of the *Memorial* flush with ground level.

- 2.3 Schedule “B”: Fees is deleted and replaced with Schedule “B” attached to and forming part of this bylaw.
3. If any part of this bylaw is held to be invalid by a decision of any court of competent jurisdiction, the invalid portion shall be severed, without affecting the remainder of this bylaw.
