CEMETERY BYLAW AMENDMENT NO. 2

BYLAW NO. 981, 2017

A bylaw to amend District of Fort St. James "Cemetery Bylaw No 866, 2009."

The Council of the District of Fort St. James enacts as follows:

- 1. This bylaw may be cited as "Cemetery Bylaw Amendment No. 2, Bylaw No. 981, 2017."
- 2. District of Fort St. James "Cemetery Bylaw No 866, 2009" is amended as follows:
- 2.1 Sections 5(p) through 5(r) are inserted following section 5(o):
 - 5(p) Columbarium Niche means an above ground *plot* in which one or two urns containing *cremated remains* may be placed inside and sealed;
- 2.2 Section 17 is amended as follows:
 - 17. A non-decomposing grave liner must be used for each *interment* other than an interment in a *columbarium niche*. Each grave liner used in the *cemetery* must be purchased from the *Municipality* or approved by the *Caretaker*.
- 2.3 Schedule "B": Fees is deleted and replaced with Schedule "B" attached to and forming part of this bylaw.
- 3. If any part of this bylaw is held to be invalid by a decision of any court of competent jurisdiction, the invalid portion shall be severed, without affecting the remainder of this bylaw.
